The college will be designated as Examination Centre by the University only if the College has minimum 50% students of total intake capacity permitted by SSUHS/ Council and the College is approved as Examination Centre by the University. Otherwise examination of students will be conducted at other designated Examination Centre which shall be notified by Srimanta Sankaradeva University of Health Sciences in due course of time.
4. This affiliation is for Academic Session 2024-25 upto 31-07-2025.
5. Application for renewal of affiliation must be submitted by the Institute before 30-06-2025.
